

BOD OPEN-LABEL OBSERVATIONAL STUDY (BODOLOS)

[ACTRN registration no: ACTRN12620000741987]

Bod is conducting an Australia-wide observational study to primarily assess the safety, tolerability and efficacy of its pharmaceutical-grade medicinal cannabis for any indication that it has been prescribed for. This is a non-interventional study that will gather valuable information on patient health outcomes during standard procedures of care, with data being collected systematically and using scientifically-validated methods.

WHO IS ELIGIBLE TO PARTICIPATE IN THIS STUDY?

You may be eligible to participate in this study if you are prescribed Bod medicinal cannabis for any indication through one of the ethics-approved study sites. You may be eligible for treatment with medicinal cannabis if you fulfil the criteria set by the Therapeutic Goods Administration (TGA):

- You have a chronic medical condition
- All conventional approved treatment options have been considered and found unsuitable
- There is evidence to support the use of medicinal cannabis for your chronic condition

HOW TO PARTICIPATE:

This study is being conducted through ethics-approved study sites where medical doctors experienced in prescribing legal medical cannabis work closely with referring doctors and specialists in a shared-care model:

STEP 1

Contact an ethics-approved clinic and mention this study to assess eligibility for consultation *(a list of approved clinics, along with their contact information can be found on the reverse side of this leaflet)*.

STEP 2

If you are eligible for consultation at an ethics-approved clinic, **you will require the following documents** from your doctor:

- A referral to the clinic *(a convenient referral form can be found on the reverse side of this leaflet)*
- Patient's health summary, including current and past medical history, and list of current and past medications that have been used for the referring condition/s.

STEP 3

At your appointment, a **doctor from the clinic will assess you and your medical history** to determine the most appropriate treatment options for the referred condition/s, including eligibility for treatment with medicinal cannabis and participation in this study.

Please be aware that a clinic consultation does not guarantee study participation.

You may be invited to participate in the study if you are prescribed one of the Bod cannabis medicines. Normal clinic consultation costs and associated fees as set by the approved study sites apply, as do the ongoing costs of the prescribed medicines. Please speak to one of the participating clinics for more information.

You will receive some financial compensation on the cost of the medicine if you are invited to participate in the study, including complimentary supply of the first two (2 x 25 mL) medicines that are prescribed.
